Kindly note that St. Leo works with natural materials which offer a unique colour and finish; we cannot guarantee that our samples will perfectly match the final goods on delivery, or the final application on the surfaces. Customers should expect some variation between batches of St. Leo products and must always check the colour received and test it before commencing the full project. If in doubt, please contact us immediately.

#### VALIDITY

These Trading Terms shall supersede and suspend all previous agreements and shall apply to any agreement made between St. Leo and the buyer unless otherwise agreed.

# SALES AND MARKETING MATERIAL

Information supplied by St. Leo regarding prices, features, and specifications in catalogues, advertisements, sales or promotional literature, price lists or elsewhere is not legally binding and shall be considered for guidance only and may be changed at any time without prior notice.

#### ORDERS

All orders placed by the buyer must be in writing and shall at the minimum specify the type (product number and/or name) and quantity of the products ordered as well as the requested date of delivery. The order is not binding upon St. Leo unless and until St. Leo has issued a written order confirmation to the buyer. Unless objections are made within 24 hours after receipt, the order confirmation is considered accepted by the buyer. For customers on prepayment terms St. Leo will start production of made-to-order products immediately when prepayment has been received.

## PRICES

The present price list replaces all previous price lists and may be subject to changes at any time without prior notice. The purchase price for the products ordered by the buyer is stated in the order confirmation. Delivery and installation are not included in the purchase price. Unless otherwise agreed, quotations submitted by St. Leo shall be valid and binding for 30 days after receipt.

## DELIVERY

Unless otherwise agreed in writing, delivery shall be DAP (Incoterms 2020) from the place designated by St. Leo. The delivery is handled by St. Leo's forwarding agent. St. Leo will invoice the transport costs to the buyer corresponding to the rates offered by the carrier. The products shall be sent using standard packaging. The time and date of delivery is an estimate only. St. Leo cannot be held liable for any damage or loss that the buyer may suffer as a result of a delay or a non-delivery. If no specific delivery date has been indicated in the order confirmation, St. Leo, acting reasonably, is entitled to stipulate a delivery date taking into consideration the quantity and the nature of the products to be delivered. The buyer is always obliged to inspect the products delivered upon receipt, i.e. checking that the correct type of products have been delivered, checking that the correct

quantity of the products have been delivered and checking they have received the desired colour. Should a delivery fail to meet the buyer's expectations, or if the delivery was damaged during transportation, the buyer shall: Inspect the entire delivery immediately, accept the delivery, but immediately note the damage on the freight documents by stating, "Received with reservation".

If freight document does not allow for reservations, the buyer is expected to refuse the delivery and report the extent of the damages St. Leo according to the paragraph "Filing Complaints". The buyer is deemed to have accepted the products delivered unless a claim has been filed within 5 working days upon receipt in accordance with the instructions in the paragraph "Filing Complaints".

# PAYMENT AND RETENTION OF TITLE

Unless otherwise agreed, payment shall be made in accordance with the payment terms and conditions of payment indicated on the invoice and the order confirmation. All bank charges are the responsibility of the buyer. All products not paid for in full, including interest and delivery (if any), shall remain the property of St. Leo. The buyer shall at all times keep such products separated from any other products held in stock and must ensure that the products can at all times be identified by St. Leo. The buyer shall be liable to St. Leo for any damage to the products until they have been paid for in full as stated above. There will be a penalty interest of 2% per month when payment is made after the due date. Such interest is payable without any further notice. Prepayment of proforma invoice is required for buyers without credit. The buyer must state account number as well as the proforma invoice number on the payment.

## WARRANTY AND LIMITATION OF LIABILITY

You must check and make sure that you have received the correct buckets and the right colour, immediately upon receival. Furthermore, you must test the product on a small surface before applying it to the entire wall. Please consult your painter for preparing the wall, before the application.

wall, before the application.

St. Leo offers a warranty against defects of manufacture and materials on standard products. This warranty shall be valid from the date of delivery provided that the products are used under normal circumstances and maintained according to guidelines.

Excluded from this warranty are all defects due to or caused by transport, incorrect use, inadequate maintenance, accidents, the buyer's alteration or repair

as well as normal wear and tear of the products. Natural variations in organic materials are not considered defects. St. Leo is explicitly excluded from all liability for any damage or loss that such defects or variations may cause, directly or indirectly. The customer is responsible for storage facilities for goods.

#### PRICES

Prices are stated excl. VAT / Incl. VAT and are valid from 01-02-2023. All prices are subject to alteration. MOQ: Minimum order quantity Notwithstanding any other provisions of these Trading Terms, St. Leo's maximum liability in relation to the buyer can in no event exceed the purchase price for the products sold, including any liability for damages to a third party, such as, for example but not limited to, product liability

## PRODUCT LIABILITY

Mandatory product liability rules in force from time to time shall apply to disputes regarding product liability. Unless otherwise required by mandatory legislation, St. Leo shall not be liable to the buyer for any damage or loss caused by the products, including but not limited to liability for loss of production, loss of use, loss of contracts, loss of profit or for any other consequential or indirect loss whatsoever.

Any information, whether verbal or in writing of any kind (including on our website), is for guidance only and is given in good faith but without warranty, since skill of application and site conditions are beyond our control. In any event we do not accept any liability whatsoever for the performance or non-performance of any goods beyond the value of those goods (for example, we shall not be liable in respect of wasted time or additional costs incurred by any person such as labour or scaffolding costs nor shall we be liable in respect of any alleged consequential losses of any person).

## REMEDIES

With respect to products that are defective, St. Leo may choose to refund the purchase price for such products, repair such products or replace such products, always provided that it is a condition for such refund, repair or replacement that the buyer has notified St. Leo about the defect within reasonable time after the buyer discovered or ought to have discovered it, and provided that such notice is given within the warrantv period in accordance with the instructions in the below paragraph "Filing Complaints". Thus, St. Leo is not obligated to replace customized or discontinued products. The above remedies constitute the buyer's only Remedies in respect of any defective products delivered under these Trading Terms.

### FILING COMPLAINTS

A complaint shall be filed by email within 5 days upon delivery and, for quality complaints, within the period of warranty. Each complaint shall be filed in such a manner that the email describes in detail the problem at hand. Each complaint will be evaluated from the St. Leo Claims Department provided that the following is stated and/or enclosed: Delivery note/order confirmation number/ invoice number, clear description of the complaint in detail, images of product, up close and from afar:

- For transport damages: Images of boxes and labelling shall be enclosed by the buyer
- 2. For quality complaints: Images of product specific PO-number shall be enclosed by the buyer.

## RETURN OF PRODUCTS

Returns are only accepted by prior written agreement. Return products shall be securely and properly packed and return order confirmation shall be placed visible on the package. Unless otherwise agreed, the buyer shall bear the transport cost and risk of any defective products returned to St. Leo. If the return has been accepted – the return has to be done within 14 days. No return of products can be accepted for Custom Colour products. Your return is subject to be charged an administration fee of 30% of the order value.

## OTHER

The buyer is not allowed to sell the products to re-sellers without prior approval by St. Leo.

# APPLICABLE LAW AND VENUE

The parties contractual relationship under these Trading Terms shall be governed and construed by and shall be interpreted in accordance with Danish law, without regard to the United Nations' Convention of Contracts for the International Sale of Goods (CISG). Any dispute that may arise out of the parties' contractual relationship under these Trading Terms or any related event, which cannot be settled amicably, shall at St. Leo's request be brought before the Copenhagen City Court.

## AMENDMENTS

St. Leo is entitled to modify these Trading Terms at any time. St. Leo shall notify the buyer of such modifications and of the date of such modification. The buyer is deemed to have accepted the modifications unless written notice of rejection is given to St. Leo within 10 working days after receipt of such notice.
